

INNOVATIVE PAVEMENT RESEARCH FOUNDATION COMPLETES RESEARCH ON WEEKEND RECONSTRUCTION OF I-10

The Innovative Pavement Research Foundation (IPRF) has released research reports and findings from an innovative project to reconstruct 2.8 lanekm of Interstate highway in a single weekend.


Research Report

A 63-page research report documents the reconstruction and traffic management effort to replace 2.8 lane-km of concrete pavement in 55 Under a contract with the California Department of Transportation, Morrison-Knudsen Corporation of Highland, California removed and replaced one of four eastbound traffic lanes of I-10 near Pomona in a 55-hour weekend closure period. The report, prepared by the University of California at Berkeley, details the entire construction process and identifies construction activities that constrained the overall project productivity.

The project utilized fast-track concrete with a 4hour curing time and was completed successfully in 55 hours. Concrete delivery to the site was found to be the constraining factor. The overall progress of the project was not found be to controlled by the demolition activities or concrete cure time.


Findings Report
